# Target applicants:

Participants 15 years old and younger who live in the UAE.

## Age Categories

(1) Category 1: Under 8 years old
 (2) Category 2: 8-11 years old
 (3) Category 3: 12-15 years old

Entry period October 1<sup>st</sup>, 2021 to January 15<sup>th</sup>, 2022 (entries accepted no later than this date)

# Entry guidelines

Please send your artwork to the office according to the following guidelines.

(1) Paper size: Strictly observe that the paper size is within 270 - 300 mm (11 - 12 in.) x 420 - 450 mm (16.5 - 18 in.) \*The above paper size equates to an A3 or a tabloid size

# (2) Artistic medium: your choice

\*You may use colored pencils, markers, crayon, water paints, etc.

However, works such as CG pictures made using a computer, collages, cut outs, etc. will not be accepted as entries. Also, "collaborative works" completed by multiple individuals on a single piece of paper will not be accepted as entries

As a rule, the artwork must be in color, and please draw a background.

### (3) Entry form

Please attach one entry form per artwork. Download the entry form from https://www.toyota.ae/world-oftoyota/toyota-dream-car/ or obtain it Toyota Dubai Festival City showroom. Please fill in all the necessary items on the entry form, and securely attach it to the back of your artwork.

(4) Incomplete forms are subject to disqualification.

- (5) Permission of the parent or legal guardian is necessary when entering the contest.
- (6) Destination address: Toyota Dubai Festival City showroom or Toyota Abu Dhabi Airport Road showroom.

## Judging

Judging will be strictly conducted in two stages. Submitted artworks will be judged and top three artworks will be selected from each age category for the National Awards Ceremony. The top 3 artworks from each age category will be announced on Facebook/ ToyotaUAE and valuable prizes will be awarded to the winners at the National Awards Ceremony.

#### Announcement of Winners

The results of the national contest are scheduled to be announced in April 2022.

# Reminders

- Submission that have previously been released, submissions that have been entered in other contests, and submissions that infringe on a third party's copyrights will not be accepted by Toyota.
- Multiple submissions are allowed from the same person. However, only one prize will be awarded per person.
- Family members of employees of TMC or TMC related companies are also eligible to participate.
- Any private information collected as part of the contest will not be used for any other purpose.
- We will be unable to return any of the artworks submitted for the final contest.
